Operator Program**

1. The rates for eligible items are provided on the Rate Sheet.
2. This offer is good only for the eligible items listed in the Rate Sheet.
3. All SLFB branded pounds purchased in the qualifying product categories shown will count toward the level achieved.
4. Please review eligible products with your SLFB or Broker sales representative.
5. The Rate Sheet is published two times per year and the effective dates are January thru June and July thru December.
6. Rebate requests must be submitted within 60 days after the end of each quarter and include purchase back-up. Back-up for this offer should be in the form of invoices or distributor reports. Distributor reports will only be accepted if they include SLFB item numbers, distributor and operator business name, appropriate dates and clear separation of purchase detail. Chain Headquarters may submit for multiple locations and request one combined rebate check. However reports submitted must show individual store addresses and purchase information.
- 7. Submissions over 60 days at the end of the quarter will be denied.**
- 8. Submissions can not be made by a 3rd party.**
9. All proposed elements of this program are based on invoiced pounds (deductions must be adjusted out) within these dates and completed submission to SLFB.
10. Payments will be processed within 6-8 weeks of receipt of proof of purchase on a quarterly basis. Quarters are broken down as follows: Quarter 1, January - March; Quarter 2, April – June; Quarter 3, July – September; Quarter 4, October – December.
11. Should there be a discrepancy in the rebate amount, SLFB will supply a detailed explanation.
12. This offer will start at the beginning of the quarter in which the enrollment is received (enrollment received on March 15th, will qualify for the entire first quarter).
13. The program will continue until either the operator or SLFB provides a 30 days in advance written notice of termination.
14. Offer valid only in the US and limited to customers purchasing through a foodservice distributor.
15. Invoices for this offer cannot be used in conjunction with any other SLFB offer except the New Product Trial Offer.
16. This offer is not valid for school or military bids and operator members of Group Purchasing Organizations.
17. All other operator programs will be reviewed prior to participation.
